



Equipment Rental Agreement

PRO SYSTEM

San Diego DJ agrees to provide equipment as rental under the following conditions: \$ _____ every 24 hours for each package. All property is owned by San Diego DJ and may not be sold, lent, mortgaged, or encumbered in any way. Any digitally stored medium including CDs and computer files are licensed to San Diego DJ and may not be copied, deleted, moved or transferred by anyone. Any item damaged, lost, stolen or not returned in good condition upon expiration of the rental agreement shall be billed to the renter for the full replacement value. By accepting delivery renter acknowledges that equipment has been inspected and is fully functional and acceptable for renter's intended purpose. No warranty is expressed or implied that equipment will suit renter's specific needs. Renter agrees to be financially responsible for all loss, damage, theft or acts of God and agrees to reimburse San Diego DJ for the full replacement value of each individual item and authorizes San Diego DJ to charge the credit card given at time of deposit for any item damaged or not returned, at the full replacement value. All items will be thoroughly inspected within two business days of return to warehouse. Renter assumes full responsibility for storage, security, use and protection of equipment until returned. Failure to return equipment within rental period will be charged for an additional 24 hours. Failure to return equipment within 48 hours of agreement expiration will be charged the full replacement value of all equipment. San Diego DJ will provide free delivery and pick-up in the metro San Diego area to a single, ground level location no more than 100 feet from delivery vehicle. The fuel surcharge rate for outlying areas is provided on the payment form. No stairs or steps beyond a normal 3 step porch. We will NOT deliver up or down stairs. Elevators are acceptable. Payments are non-refundable. Renter or designated person MUST be present for all deliveries and pick-ups. Gate codes, parking fees, access fees, permits, licenses, insurance and/or permissions are the responsibility of the renter. Delivery delays caused by failure to provide access are the responsibility of the renter and no credit is provided for lost time. San Diego DJ reserves the right to refuse delivery if in our opinion it is unsafe or poses a risk. If trouble is encountered operating the equipment please call 858-220-6070 immediately to report the problem. We will attempt to help you resolve the issue by phone. If a technician is dispatched and the equipment is not at fault (the power cord got unplugged etc), or the problem was addressed during the phone call, you authorize a \$100 service fee to be charged to your credit card. San Diego DJ is not responsible for interfacing renter's own equipment with our equipment. San Diego DJ assumes renter is familiar with the basic operation of standard audio/video equipment. Equipment may not be removed from the setup location without express written consent in advance.
